



## I. Introduction

### a. Timeline of Jesus birth & childhood

- Lk 1:5-25 Conception of John the Baptist
  - \* parents Zacharias & Elizabeth
- Lk 1:26-38 Angel Gabriel visits Elizabeth at 6 months pregnant
- Lk 1:39-56 Mary visits Elizabeth for 3 months
- Lk 1:57-80 Birth of John the Baptist
- Mt 1:18-25 Mary returns home to Nazareth 3 months pregnant
  - \* Joseph thought private divorce
  - \* But Joseph receives dream to marry Mary

### b. - Lk 2:1-7 Birth of Jesus (See Is 61:1-2)

- Lk 2:8-20 Shepherds visit Jesus in animal stable
- Lk 2:21-24 Jesus circumcised
- Lk 2:25-35 Simeon meets Jesus in temple at Jerusalem
- Lk 2:36-38 Anna a prophetess meets Jesus in temple also
- Mt 2:1-12 Wise men meet Jesus in Bethlehem
  - \* Jesus a young toddler (2 yrs)
- Mt 2:13-15 Joseph flees to Egypt with Mary & Jesus
- Mt 2:16-18 Massacre of the Innocents

1b. (cont)

- Mt 2:19-23 Joseph, Mary, & Jesus return to Galilee (also Lk 2:39)
  - Jesus attends Passover at Jerusalem at 12 years old (Lk 2:40-52)
2. Jubilee Year Sabbath - Undeserved
- a. Lev 25:1-4: Seventh year of agricultural sabbath rest every 7 years (fallow year)
  - b. Lev 25:8-55: Year of Jubilee
    - 50<sup>th</sup> year of Sabbath rest  
from & redemption
    - \* 50<sup>th</sup> year immediately followed after 49<sup>th</sup> year of Sabbath rest (25:11)
  - c. Ram's horn blown on 7th month on 10th day in harvest season
    - Feast of Trumpets (Lev 25:9)
3. To Remember
- a. Proclaim liberty (Lev 25:10)
  - b. Remember God's goodness (Lev 25:18-22)
  - c. Remember to release captives & debts (Lk 4:16-21 in Nazareth)
  - d. Picture & type of Messiah
4. To Release - Not earned
- a. Inherited lands returned to owners debt free
    - mortgages & leases on inherited lands
    - Lev 25:13-17
  - b. No permanent land sales (Lev 25:23)
    - c. Year of Jubilee for forgiveness/freedom
5. To Redeem (Lev 25:24-28)
- a. Relative redeem (buy back) land
  - b. Redeem person from slavery (Lev 25:47-48)
  - c. Poor in servitude (Lev 25:39-43)
6. To Rest
- a. Jubilee year of rest & restore status
  - b. Return people to liberty
